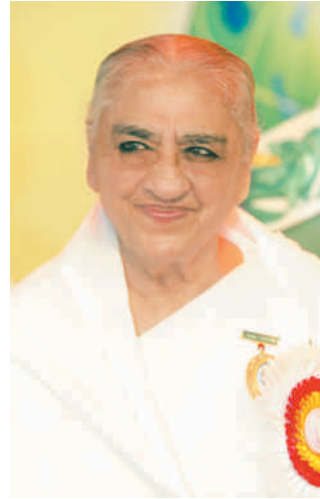
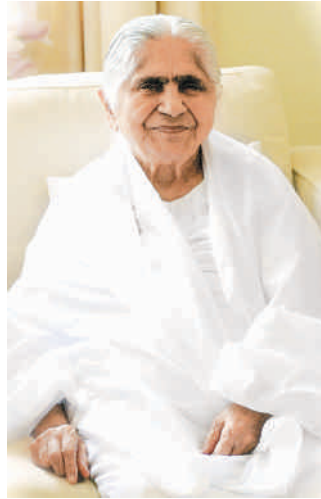

We crossed a major milestone last year—25 years of operations at J Watumull Global Hospital & Research Centre, Mt Abu. We started out in a humble way. Today, our staff, friends and well-wishers make up one large family. Our story is one of relentlessly providing quality health care with a spiritual touch to thousands of people in and around Mt Abu. Wherever possible, we have partnered with the government to deliver national health programmes. We acknowledge the cooperation of the global Brahma Kumaris family which has stood by us all these years.

We lost Raghunath L Wadhwa, an esteemed trustee and former chairman of Allahabad Bank last year. Ramesh Shah, additional secretary general of the Brahma Kumaris and an avid supporter of the hospital, also passed away as did a great friend, Dr Gyan Prakash, the former Director of Health Services Rajasthan. Salutes!

A landmark achievement in 2016 was commissioning a state-of-the-art CT Scanner and digital x-ray, with the support of generous donors, especially the Janki Foundation for Spirituality in Healthcare and the Prajapita Brahma Kumaris Ishwariya Vishwa Vidyalaya.

We created a skills lab for our resident doctors and nurses.

Consultants, residents and staff at Global Hospital Institute of Ophthalmology set new records—943 surgeries in a month, and 1997 patients screened in one day at an event in Sojat City.

Rotary International Global Hospital Blood Bank achieved a commendable target—99.96% voluntary blood donors. Having only 0.04% replacement donors is a big effort.

Muskan Mela brought together 65 children we have operated on for a cleft deformity. They interacted with Dr A Gopalakrishna and Dr Sharad Mehta, our Smile Train accredited surgeons.

We felt proud to support *Bhamasha Swasthya Bima Yojna* a path-breaking government health insurance scheme for below poverty line patients.

A mentoring role that materialised through the Public Health Foundation of India saw us train ophthalmologists, physicians and paramedical staff employed in the public health sector in Pali, in diabetic retinopathy care. The Queen Elizabeth Diamond Jubilee Trust of the UK is funding this blindness prevention initiative.

We renovated and equipped our Intensive Care Unit at the Radha Mohan Mehrotra Global Hospital Trauma Centre. Gratitude to the family of late Shri Baijnath Luharuka of Kolkata.

Automated biochemistry analysers were installed at Mt Abu and Abu Road.

Four new dialysis machines donated by the DaVita Health Care Partners of the USA are proving a boon for the growing number of kidney failure patients at our Mt Abu and Abu Road units. Nephrologist Dr Rahul Prakash of Texas, USA,

connected us with Bridge of Life, the charity which routed this donation. We are also grateful for nephrologists Dr Anandnarayan Malu and Dr Manjunath Doshetty's periodic visits. A dialysis patients fund sustained with Sujata Rathi's effort helps meet the cost of poor patients' treatment.

Much gratitude to Swaran Singh and Baljinder Kaur of UK, and their daughter Kalwinder of Australia for sponsoring the creation of a Vision Centre in Pindwara, our third such clinic offering eye checks and referrals to the base hospital.

We gratefully acknowledge our partnership with Zorg van de Zaak, a Dutch not-for-profit that is supporting our community outreach clinics, nursing education and a pioneering exchange programme for nursing professionals. We enjoyed hosting Corielle Rovers and Jacqueline Prudhomme van Reine, ICU and burn care nurses.

Now we are a recognised primary treatment centre for persons covered under the Employees State Insurance Act. Dermatologist and Village Outreach Programme head Dr Kanak Shrivastava is managing this clinic at Mt Abu.

The coronary artery disease regression through lifestyle changes and holistic approach to diabetes programmes are making good on our commitment to holistic healthcare, benefiting hundreds of patients. Kudos!

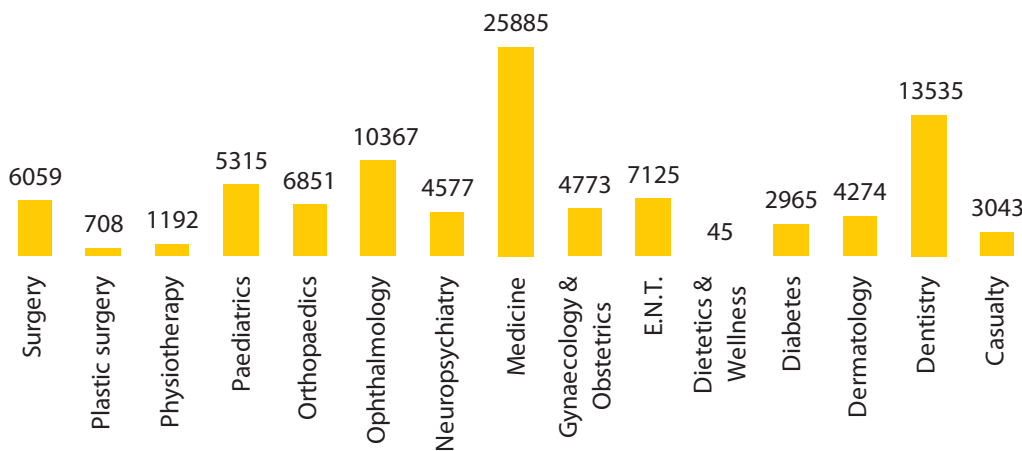

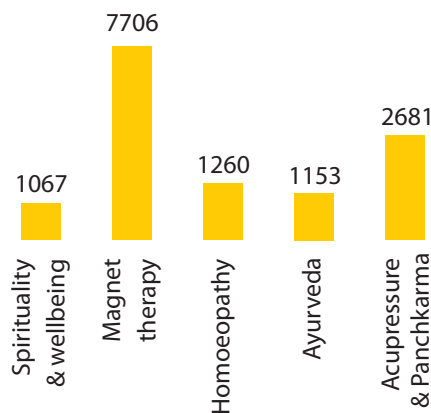

Diagnostic Services

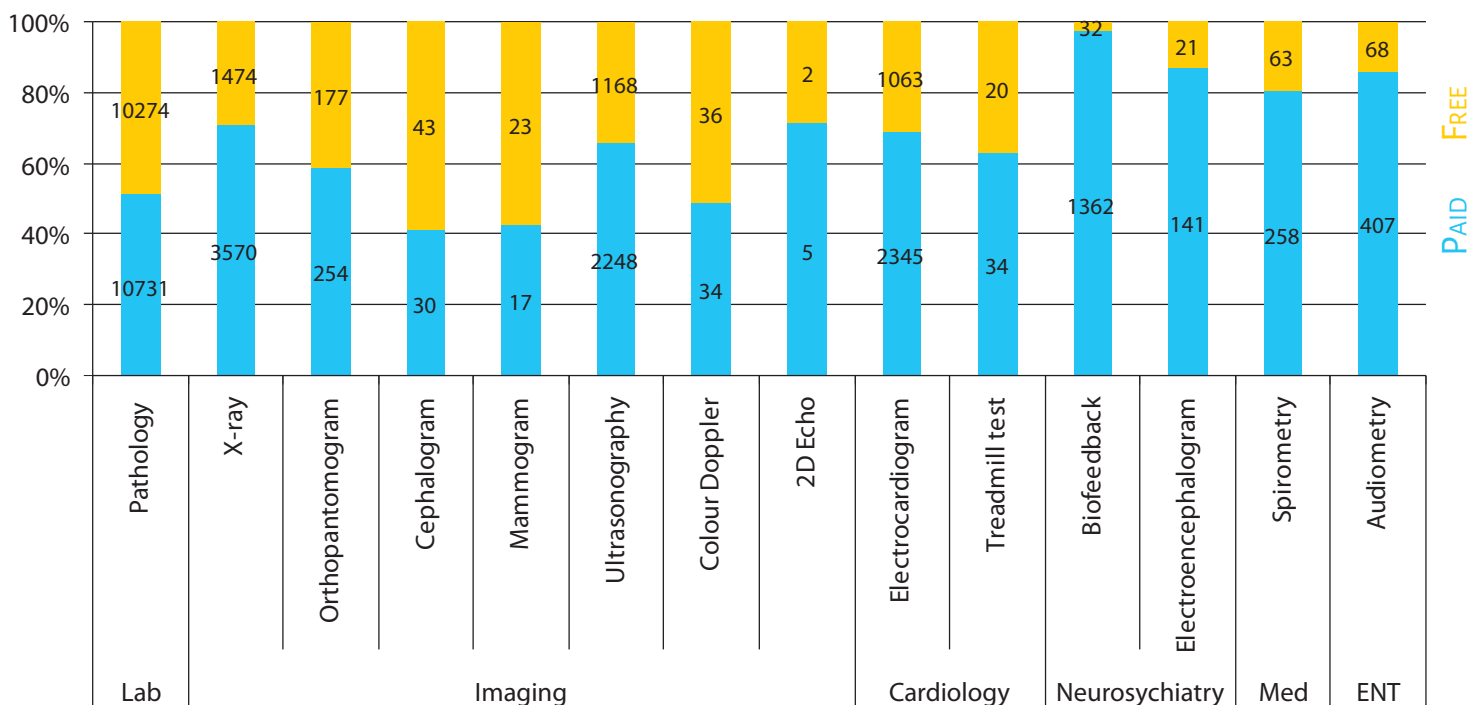
Pathology laboratory: 24x7 processing, adhering to stringent external and internal quality standards, by means of modern equipment and instrumentation.

Blood storage centre: units are requisitioned from blood banks,

stored, cross-matched for patients and issued for transfusion.

Imaging: digital x-rays, mobile x-rays and special procedures like barium studies, intravenous urography and myelography.

Scope-aided investigations: general surgery: gastroscopes, cystoscopes; gynaecology: hysteroscopes; ENT: nasal endoscopes, laryngoscopes.

- >> to solve technical and clinical problems of the region it oversees.

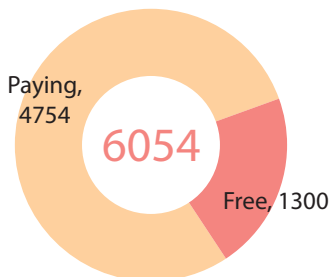
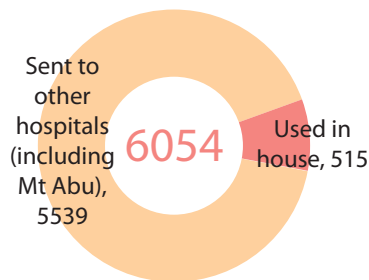

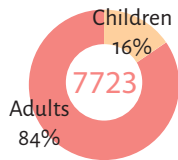
How the processed units were distributed

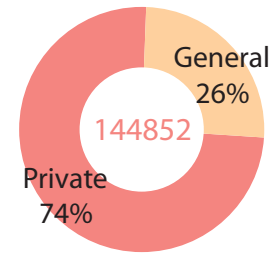

The mobile medical clinic team comprised of doctors, nurses and paramedical professionals visits the neighbouring slum and rural areas offering home visits, check ups, medication, educative health talks, and referrals to government hospitals.

Healing with a Spiritual Touch

A team of sisters proficient in spiritual education helps bring into practice the hospital motto, *Healing with a Spiritual Touch*. They offer spiritual counseling services to patients and patients relatives. They conduct meditation courses for new staff, lectures and self development programmes for all staff and weekly spiritual classes for interested staff.

Dr Sushanta Pai, appointed paediatrician, neonatologist & lactation consultant in June 2016, has launched a Child Care Centre.

Events & Health Initiatives

- >> Eighty medical and paramedical professionals attended three-day *Values in Healthcare: A Spiritual Approach* facilitator training in June 2016 at the Reliance Energy Management Institute, Mumbai.
- >> 269 people took benefit from free hepatitis B and hepatitis C screening and moderately-priced immunisation in July 2016, offered in association with the Liver Care Foundation and Lions Club of Juhu.
- >> 103 people took benefit from free screening for mouth and throat cancer between July 25 and 29, to coincide with the World Head & Neck Cancer Day.
- >> 45 seniors took benefit from prostate cancer screening in December 2016.
- >> A team of doctors and paramedics and the cardiac ambulance supported 56 adults and 150 girl students participating in a 4 km run for women's dignity, *Sakhi Minithon 2017*, organised by the Ghatkopar subzone of the Brahma Kumaris on January 29. Free bone mineral density and random blood sugar tests were offered as well.

Community Service Project

A mobile health consultation service for 56 villages in Abu Road, Pindwara and Reodar



MODUS OPERANDI | Two doctors offer health consultations while their attendants dispense medicines. They refer serious cases to Global Hospital.

WHERE IS IT BEING IMPLEMENTED | In 56 villages in blocks Abu Road, Pindwara and Reodar of district Sirohi, a population of about 150,000.

WHY IS IT BEING IMPLEMENTED | To plug a gap in existing health services. For most of these villages, the nearest Primary Health Centre is 5 to 20 km away. Travelling to and fro to see a doctor takes up the better part of a day, and means losing a day's wage.

SINCE WHEN IS THIS PROJECT OPERATIONAL | 2004

CURRENT SPONSOR | Zorg Van De Zaak Foundation, Holland; Educate for Life, meets 50% of the Bakhel visit costs

BENEFICIARIES | 27420 new, 3287 follow-up patients, 1274 referrals, including 14269 children (0 to 15 years) 12507 adults (16 to 60 years), 3931 seniors

Village Outreach Programme

A doorstep health service operating in 21 villages around Mt Abu

MODUS OPERANDI | The doctor makes periodic visits to the adopted villages. Affording patients pay Rs 10 towards the cost of medicine, poor patients are exempted this charge. Health workers accompany patients needing further treatment to the hospital.

WHY IS IT BEING IMPLEMENTED | To plug a gap in available health services. To spread awareness about the availability of modern medicine and encourage patients to step into Global Hospital.

WHERE IS IT BEING IMPLEMENTED | In villages Aarna, Achalgarh, Chandela (Telapurphali, Ambaveriphali, Bageri, Khadraphali), Hetamji, Jaidra, Jamburi, Jawaingaon, Kyaria, Nichalagarh, Oriya, Salgaon, Shergaon, Siawa, Takiya, Tuka, Uplagarh, Utteraj

SINCE WHEN IS THE PROJECT OPERATIONAL | 1991

SPONSORS | Individual philanthropists

BENEFICIARIES | 5096 patients on site, 4479 stepped in for consultations, 209 hospital admissions

Vitamin A Supplementation

In 2016, the Global Hospital & Research Centre entered into an agreement with Vitamin Angels, an international not-for-profit that ties up with grassroots agencies to provide vitamins to children under five years of age at risk of malnutrition, to reduce the incidence of preventable illness, blindness and death.

Vitamin Angels is providing Global Hospital vitamin A supplements and deworming tablets for distribution through the Village Outreach Programme and the Community Service Project.

The work of Vitamin Angels complements the government initiative involving the administration of a dose of vitamin A at nine months. This, doctors say, is insufficient.

Up until March, these outreach teams administered Vitamin A supplements to 314 children aged 6 to 12 months and 883 children aged 12 to 59 months. Deworming tablet beneficiaries included 937 children, age 12 to 59 months.

Tuberculosis Project

An initiative for the early detection of tuberculosis and improvement of patients' nutritional status

MODUS OPERANDI | 46 field workers identify suspect tuberculosis patients from among 200,000 residents of 62 villages. To confirm the diagnosis, the sputum samples are tested at Radha Mohan Mehrotra Global Hospital Trauma Centre or J Watumull Global Hospital & Research Centre, designated microscopy centres under the Government of India's Revised National Tuberculosis Control Programme.

Patients testing positive are started on Directly Observed Treatment, Short Course, the World Health Organisation-prescribed treatment regimen. Field workers personally administer each dose to ensure patients' adherence to

the six month regimen, failing which the patient may develop drug-resistant tuberculosis. Field workers also distribute nutritional supplements to the patients.

WHY IS THIS PROJECT BEING IMPLEMENTED | Timely detection and treatment checks the spread of tuberculosis. The nutritional supplements help patients, most of whom are from food insecure families, to gain weight and improve treatment outcomes.

SINCE WHEN IS THIS PROJECT BEING IMPLEMENTED | 2008

SPONSORS | Government of India (medicine and project supervision), GiveIndia (nutritional supplements), PlayGames 24x7 Pvt Ltd (nutritional supplements and field workers incentives for identifying suspect patients).

BENEFICIARIES | 806 sputum samples tested, 169 positives; 85 cures over the year; 50 patients on treatment at the year end



Puni Garasia, 14, a tribal, weighed barely 20 kg when she was detected with tuberculosis in October 2016. Her Body Mass Index was 9.9 kg/m², well below the desirable 18.5 kg/m². Undernutrition is the stark reality of 90% of pulmonary TB cases in India. Puni gained 6 kg while she was on treatment and receiving the nutritional supplements.

Nutritional Project

Students of public schools in 17 of the 21 adopted villages (see Village Outreach Programme) are served a milk-based snack and fruit during school hours.

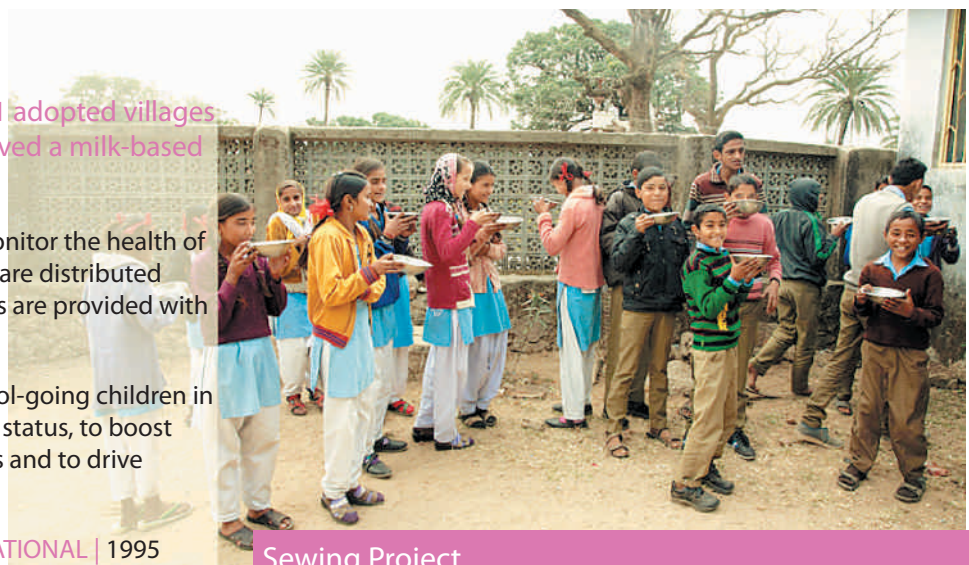
The VOP team conducts annual checks to monitor the health of children. When funds are available, students are distributed learning aids and warm clothing, and schools are provided with extra infrastructure.

WHY | To boost the nutritional status of school-going children in the adopted villages, to monitor their health status, to boost school attendance rates, to reduce drop-outs and to drive school enrolments.

SINCE WHEN HAS THIS PROJECT BEEN OPERATIONAL | 1995

Sewing Project

In villages Chandela and Oriya, the Village Outreach Programme team arranges sewing classes for women/girls. Skilled 'pupils' then help their teachers stitch the uniforms for students of schools where the nutritional programme is running.

The Smile Train

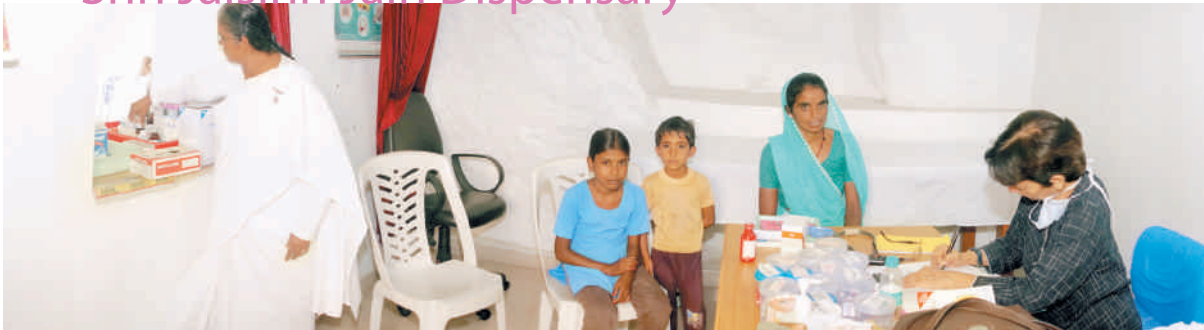

Visit ~ South African Partner

Dr L N Mlisa, a research fellow from the University of Fort Hare South Africa, a partner institute of J Watumull Global Hospital & Research Centre, visited Mt Abu and Abu Road between November 22 and 28. Her visit was funded under the International Academic Exchange Program via the Govan Mbeki Research and Development Centre.

Dr Mlisa attended the Coronary Artery Disease Regression Through Lifestyle Modification seven day camp with Dr Satish Gupta, director, Medicine & Cardiology, Radha Mohan Mehrotra Global Hospital Trauma Centre to assess the programme's suitability to South Africa. She met with the principals and staff of the school of nursing and nursing college, and identified possible collaboration areas with the School of Nursing at the University of Fort Hare and nearby rural hospitals. She made a presentation to the staff on how institutions of higher learning in South Africa support the national development goals and the government in servicing people with chronic diseases such as HIV/AIDS, diabetes and cardiac ailments. She identified a large number of potential

research projects in the hospital and proposed utilising nursing students and staff in the writing of papers.

Applied Research

In the late nineties, J Watumull Global Hospital & Research Centre co-conducted a study to assess the effect of lifestyle changes: Rajyoga meditation, exercise and a vegetarian diet on regressing coronary artery disease. Defence Institute of Physiology and Allied Sciences, Defence Research & Development Organisation, New Delhi, co-conducted this study while the Central Council for Research in Yoga & Naturopathy, the Ministry of Health and Family Welfare, Government of India, and the Defence Research & Development Organisation, New Delhi, sponsored the project. Mount Abu Open Heart Trial, a paper on the findings was published in September 2011 in the Indian Heart Journal.

Dr Satish Gupta, director, Department of Medicine & Cardiology, Radha Mohan Mehrotra Global Hospital Trauma Centre, developed the 3D Healthcare Model, a seven-day residential programme based on this study, to inform patients how to implement lifestyle changes that bring spiritual, mental, and physical wellness. During the year, 434 patients took benefit.

Since 1999, the hospital runs a three year diploma in Ophthalmic Techniques in affiliation with the Federation of Ophthalmology and Optometry Research and Education College, New Delhi. Currently, 40 students are enrolled with Global Hospital Institute of Ophthalmology.

post graduate education

Ophthalmology

Since 2013, Global Hospital Institute of Ophthalmology has been a National Board of Examination-accredited institute for post graduate training in ophthalmology. This Board is an autonomous body under the Ministry of Health, Government of India, established to standardise postgraduate medical education. It confers the Diplomate of National Board (DNB) degree.

Global Hospital Institute of Ophthalmology offers two primary DNB seats in ophthalmology for candidates holding a graduate degree in medicine (MBBS) (three year course), and two secondary seats for candidates holding a Diploma in Ophthalmology (DO/DOMS) (two year course).

Last year, Dr Swati Goel and Dr Vineet Ashish were enrolled for the three year course. Dr Suba Ronak D and Dr Annu Chahar entered their

second year while Dr Navjot Kaur, Dr Abhimanyu Gadakh and Dr Kamlesh Damor moved to the final year.

Family Medicine

J Watumull Global Hospital & Research Centre was accredited by the National Board of Examinations for post graduate training in family medicine in 2013. It is the only institution in Rajasthan offering this course, and one of about 500 institutions across India offering DNB programmes. Graduates in medicine (MBBS holders) can apply for two primary seats, entailing three years training. Candidates holding a diploma in Geriatrics or in Mother and Child Healthcare from IGNOU can apply for two secondary seats, entailing two years training.

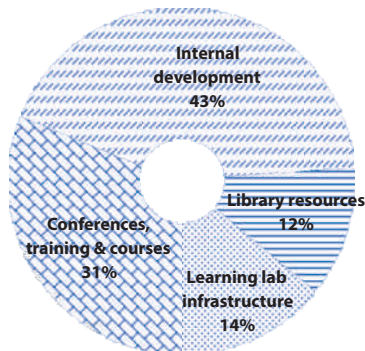

Towards Compliance With National Accreditation Board of Hospital (NABH) Standards

Policies & procedures

Dr Medha Kelkar, NABH consultant from Pune made three visits to help with compliance audits, policy writing, staff development and re-establishment of the Safety Committee. Her inputs helped set up a HAZMAT kit and HAZMAT training for housekeeping staff and the HAZMAT team on August 1 and 2 respectively, procure special storage for cleaning products, identify hazardous materials, redesign consent forms, introduce crash carts in the pathology department and TMT room for quick response to cardiac arrest, plug deficiencies in signage and finalise policies: Care of Vulnerable Patients and End of Life Care. She made five presentations for hospital staff.

Mock assessment

Dr J L Meena, state quality assurance officer, Gujarat, and Dr Hansa Goswami, dean, B J Medical College, Ahmedabad, conducted a mock assessment against the NABH Standards on September 10-11, scoring the hospital at 672.5 on 1030. Three chapters (Responsibilities of Management, Facilities Management & Safety and Information Management Systems) received full compliance while seven chapters received partial compliance. Improvements from this review included the creation of a breast feeding room near the Paediatric Department, redesign and refurbishment of the Pathology Department for patient's convenience, etc.

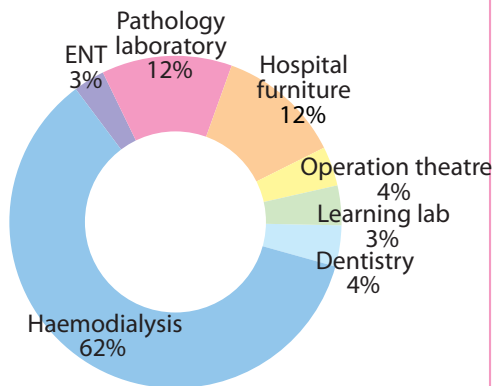

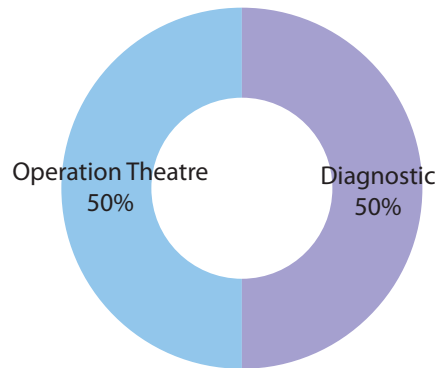

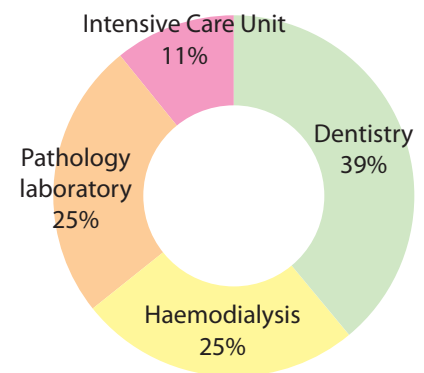

Notes to the Balance Sheet and Income & Expenditure Account for the year ended March 31, 2017

Significant Accounting Policies

System of Accounting: The Trust adopts the accrual basis in the preparation of its

accounts. As such the financial statements are prepared under the historical cost convention on accrual basis and under the going concern assumption, in accordance with the generally accepted accounting principles.

Inflation: Assets and liabilities are recorded at historical cost.

Fixed Assets: Fixed assets are capitalised at cost and are stated at historical cost. At each Balance Sheet date, an assessment is made as to whether there is any indication of impairment in the value of assets. Impairment loss is recognised whenever the carrying amount of an asset exceeds its recoverable value.

Investments: Investments are valued at cost.

Inventories: Inventories such as stock of surgical, sutures, medicines, pathology chemical, x- ray films are valued at cost or net realisable value whichever is lower and are physically verified and certified by the management.

Sundry Creditors / Debtors: Sundry creditors and debtors are subject to confirmation from them.

Receipts:

1. Hospital Receipts:

OPD Receipts: It is accounted on accrual basis on the date of providing hospital services/facilities.

IPD Receipts: It is accounted on accrual basis on the date of billing as and when the patient is discharged. However billing is done upto March 31 of every year.

2. Medical Stores Receipts: Purchases and sales of GHIO Medical Stores (Talheti) and GHRC Medical Stores (Mt Abu) are accounted at net of inter branch transfer.

3. Donation Receipts are accounted on receipt basis on the date of receipt.

Donation received towards specific / corpus fund is transferred to respective fund as per the direction of the donor.

4. Interests on bank fixed deposits and investments are accounted on accrual basis.

5. Grant-in-aid from the government is accounted as and when it is sanctioned and reasonable certainty of disbursement of claim.

BSES MG Hospital, Mumbai: In compliance with the directions of the Honourable Mumbai High Court, a sum of

Rs 101,04,241 being 2% of the gross receipts is set apart and credited to a separate fund called "Indigent Patients Fund" for the benefit of indigent patients to be spent in the manner specified under the scheme framed by the Honourable High Court.

Depreciation: Depreciation on fixed assets is provided for on the written down value method as per the rates shown against each asset as under:
> In case of assets held on April 1, 2016, for the full year
> In case of assets purchased and capitalised during the year, for half year irrespective of its date of purchase.

Gratuity: The trust has opted for Group Gratuity Scheme with Life Insurance Corporation of India for the benefit of employees.

Contingent liabilities not provided for: Nil

Claims made by other parties not acknowledged as debt: Nil

Bank guarantee: FDR of Rs 1 lakh purchased from State Bank of India Mt Abu Branch given as bank guarantee to ECHS Regional Centre, Ahmedabad.

Payment made to trustees and / or their relatives: The hospital has paid professional charges to Medical Director Dr Ashok R Mehta (Trustee) for professional services rendered by him which is considered reasonable. Rs 43,617 is recoverable from one regular customer who is a relative of one of the trustees against supply of medicine. The same is recovered in the subsequent year.

Donation:

1. 100% exemption: The Trust is notified u/s 35 AC of the Income Tax Act, 1961 for its project J Watumull Global Hospital & Research Centre. During the year the Trust has collected donations of Rs.3,79,04,107 under the said project.

2. BK Healthcare Fund: The Trust has launched a donations drive programme in the past years to raise funds for a specified purpose i.e. BK Healthcare Fund. Under the scheme, the Trust will raise funds and invest in specified securities. The income of the fund will be applied for medical purposes for poor and needy people. During the year the Trust

managed to raise Rs 36,80,432 under the scheme.

Internal Audit: Internal Audit of the trust units (except BSES MG Hospital, Mumbai and Brigadier Vora Clinics, Baroda) are carried out by M/s GMJ & Company, Chartered Accountants, Mumbai. We have considered their reports for finalising the accounts.

Accounts of BSES MG Hospital: Accounts of one branch BSES MG Hospital, Mumbai, are audited by M/s N G Thakrar & Company, Chartered Accountants, Mumbai. Similarly accounts of GHRC Medical Stores and GHIO Medical Stores branches at Mt Abu and Abu Road respectively are carried out by M/s GMJ & Company, Chartered Accountants, Mumbai. We have relied upon their audit report and statements for merging them in the main accounts.

Previous Years Figures: The figures of the current year and previous year have been re-grouped and re-arranged wherever necessity arised.
